Provincial Cannabis: A letter was received from the AUMA expressing the

disappointment in the new provincial grant program underfunding for the Cannabis Transition Program. Only

52 towns, cities, and urban service areas will receive minimal funding.

Council directed the C.A.O. to send a letter to the Province expressing Castor's disappointment with this decision.

Purchase of AltaGas: Altagas has recently sold their Commercial and Industrial

energy supply contracts to Birch Hill Equity Partners
Management Inc. The Town of Castor, through 8760 has
a power contract with Altagas to supply power to the
Town. It is expected the transition will go smoothly with no

customer service issues.

Old Business:

Christmas light options: Council was presented with a street light Christmas

decoration option.

It was discussed at length and Council felt that new decorations could be made in the community. Councillor

New Business:

Arena Paint: Paint for the Arena Renovation was planned to be taken out

of the contingency. It will run just over \$5,000.00 plus the

cost of the painter - \$3,500.00.

Playground Sign: A request was made to place a "Caution, Slow Down,

Pedestrian Traffic" sign at the top of the beach hill on both the Town side and the County side. The County has already approved the placement and will order two signs —

we can purchase one sign from them.

\$6,000.00 and \$7,000.00.
