

BOARD OF SELECTMEN
Meeting Minutes

August 12, 2019

CALL TO ORDER: Sonny opened the meeting with the pledge at 7:05PM.

SELECTMEN IN ATTENDANCE:

Joanne said that it would be a good thing to do this because the Board and committee could have joint meetings and shorten the budget process. Three were in favor, one was opposed, and one did not raise their hand.
- Joanne read the resignation letter from Sue McIntyre. Wendy **motioned** to accept. Joanne **second**. **All** were in favor.
- Sokokis Lake Association Labor day activities letter, Dottie **motioned** to accept that. Wendy **second**. **All** were in favor.
- Wendy brought up getting back into taking care of the policies and getting back into discussing them. She also told the people about the meeting that the Handicapped Accessibility and Revitalization committee had with John Cleveland and that they are starting to move forward with the repointing of the Brick Town Hall. Also it was brought up that the bids for the sewer and water project on Main Street would be going back out for bid in January.
