ANNUAL FIRE CHIEFS REPORT 2013

Good day everyone thank you for taking time to attend.

Let me start out by thanking these individuals sitting up here as well as all the individuals in attendance who have worked so tirelessly again this past year.

For those who do not know me my name is Leo Bos and I am your Fire Chief. I have held this position for the last 5 years.

During the past year we did not have any major fires, we did have a few minor calls.

We are currently running with 9 firefighters and desperately need volunteers, As this is a physically demanding job you can imagine how tiring it can be to work a fire for hours with little or no relief coming. The need for fire fighters has never been greater. So if you or any one you know has the time and ability to help please join before we are forced to close the doors.

We still have joint responses with Garden village. But when dealing with a fire time is important and the garden village department is a minimum of half an hour away so you can see how much ground can be lost.

So let's try to be proactive and get the volunteer numbers up so we can offer you and your neighbors the protection you deserve.

Thank you for your time this afternoon.

Good afternoon neighbours.

I did take the position of Vice-President last year with the understanding that there was to be changes and the board would now operate with open books and clarity.

The review of the Bylaws and the Sops started out very positive and we did all agree to the opening statement:

What the not-for-profit sector is all about.

"It's about capacity-building, transparency, accountability and knowledge-sharing. It uses the best practices of the private and public sectors for the economic, health and social benefits of the community members."

Sorry but that is where it ended.

The Board you elected last year had little to no say on the spending and functions of the board. Two people dictated everything with no accountability.

Motion #153: by Terry Brent "That all agreements or contracts for services that JBCS provides be made with the JBCS and approved by the JBCS Board of Directors, this is to include agreements negotiated by the Fire Chief on our behalf." - Seconded by Catherine Pike. - Motion Carried.

Never happened! The DND contract we think was renewed, but the cheque was sent to JPLA. No board member seen or approved this, along with many other things; check the minutes for lack of motions to spend your funds.

ction 3.2 Fire Protection and Member Privileges

- a) The annual fire protection fee will be determined at the Annual Meeting held in September and will be payable one year in advance. The JBCSI Board will determine the manner of collection.

JOCKO BEAUCAGE COMMUNITY SERVICES INC ANNUAL REPORT OF THE TREASURER SEPTEMBER 2012-AUGUST 2013

Mister President, fellow Board members and community members, I appreciate the opportunity to present the annual report of the Treasurer.

I am pleased to report that JBCSI continues to enjoy a stable and positive phase, from a financial point of view.

The corporate returns and HST rebate claim for fiscal year 2012 were prepared by Jeannine Morin and submitted on March 5, 2013. We showed a net income of \$10,044.00. Our HST rebate was \$4,942.00, and our bank balance at the end of 2012 was \$16,721.48, mainly owing to the HST rebate of \$10,500 for 2011, which was deposited in October.

As always, I am very grateful for Jeannine's valuable assistance in auditing our books and preparing our returns. In addition, Jeannine offers me the advice I need to do my job as well as possible.

I would like to provide some information about transactions since last year's AGM.

During the period from September 1, 2012 to August 31, 2013, our income was \$59,146.00 and our expenses were \$59,062.00, plus \$5,900 in loan payments and \$1,650.00 in changes to the building and equipment. Fire-protection fees and dues brought in about 53% of our income, while fundraisers, donations and bar sales account for the other 47%. The HST rebate for 2011 definitely helped make the loan payments.

As of August 31, 2013, our bank balance was \$5,571.12.

The entire insurance premium for 2013-2014 (\$11,364.00) was paid in July.

There have been a number of major expenses since the last AGM:

- The security system was upgraded and we switched to a different monitoring company, all of which cost about \$1,260.00
- The water-supply system needed to be repaired on an emergency basis, at a cost of \$1,600.00. (Many thanks to Rob Lacasse, Leo Bos, Jr., and Leo Bos, Sr.)
- The generator was installed over the course of a couple of weekends this summer. Two quotes that we received for this job ranged between \$4,000 and \$6,000. Then Rob Lacasse, an electrician who is a Jocko Point resident, volunteered to do the work for the cost of materials only, as long as our Fire Chief helped him. Thanks to the donation of some materials, the cost came to only \$800.00. As recently as the August Board meeting, four Board members insisted that a committee should have been struck to evaluate these offers and choose the one that was best for the

community. In fact, the donation of expertise and time by our residents is extremely precious, and I would like the minutes of this AGM to include an expression of our heartfelt appreciation to Rob and Leo. I can't speak for the community, but would ask that you indicate, by applause, whether you agree that we are all grateful for their work, and that taking them up on their offer was clearly in the community's best interests.

- A roof was built over the generator, and a fence was put up around it, at a cost of \$715.00. (Many thanks to Leo Bos, Sr., and Leo Bos, Jr.)
- The Fire Department's promotion budget was stretched to accommodate the purchase of fireworks and related materials, at a cost of \$1,485.00.

At the January Board meeting, at the request of Terry Brent, the bar float was increased by \$400.00, to a total of \$650.00. This allowed him to be reimbursed for purchases he made for the Rainbow Darts Fun Nights prior to the Board meeting. While the function sheet for the January-February Fun Night session reflected the deduction of these liquor expenses from the proceeds of the first few weeks, the money was not, in fact, returned to the lockup when the Fun Night sessions finished in April. When Terry was asked to return the float at the June Board meeting, he returned only the initial \$250.00 in August. This JBCSI asset has consequently been unavailable for several months, and does not appear in the Balance Sheet.

A Finance Committee was set up to review budgets and financial transactions and make recommendations concerning our funds.

In the coming year, income will probably just cover expenses. Expected expenses include reshingling of the Fire Hall roof, stripping and waxing of the floors, and cleaning of the inside of the range hood.

Many thanks to all of the volunteers and supporters of our fundraisers and of our Fire Department for making this a financially successful year.

Kitchen report 2013

As kitchen director, my duties include supervising the kitchen practices, and arranging training courses for food handling, which this year will take place in November. Date yet to be confirmed.

The kitchen director is also responsible for seeing that all usual and staple foods are on hand on a timely basis for scheduled event. This part of the position requires weekly research on pricing to know where to get the most for least. As we are in the fund-raising business, it is to be noted, that our wholesale supplier is one of our most expensive sources and I use them only when I cannot buy the product elsewhere for less.

We have been very busy this year in the kitchen, as most of you know.

Altho Breakfast numbers are down with the loss of the AA group attending, Brunch numbers continue to increase.

Our gross income from these events was approx \$19500.00. The net profit was approximately \$10225.00.

Included in these expenses was the purchase of 6 dozen new dinner plates and 9 dozen additional dinner forks which makes it easier to keep up with resetting tables at the brunches.

We are continuing to pursue the kitchen grant as the need increases with the increase in Brunch attendance.

Again this year the kitchen has become the main source of fund raising for the Community centre and Fire hall needs.

The Board and Auxiliary are both thankful that we have been able to receive the help of several younger members of the community, we older volunteers are very much enjoying having their good humour, companionship and energy available to us.

Congratulations to all who have been involved in making it happen.
