
Presentation Summary:

In response to the continuously changing construction industry, several Canadian Provinces such as Ontario and Nova Scotia have updated their construction law legislation to be more responsive to modern construction law issues. The major changes being considered are the addition of prompt payment, expedited resolution and revamping of the Mechanics Lien Act.


