

BOARD OF SELECTMEN
Meeting Minutes

August 19, 2019

CALL TO ORDER: Sonny opened the meeting with the pledge at 7:05PM.

SELECTMEN IN ATTENDANCE:

MINUTES:

- Wendy **motioned** to approve the minutes for August 12. Dottie **second**. **All** were in favor.

OLD BUSINESS:

- Dottie brought up the printers and that she had talked to the Canon representative and she said that they would send a check for the buyout of the Selectmens Secretary's printer because the contract still has a year and a half left on it. The Board decided to put it off until everyone could take a look at the paperwork for it.

NEW BUSINESS:

- Wendy brought up the milrate and that it should be ready to be set by next week and that it came out to be 15.75, Sonny said that it is in the wheelhouse of what he had come up with and that they do not want it too high or too low because we do not want sticker shock next year. So they decided to set the milrate next week.
- The Board opened the bids for the Mowing and Snowplowing for Town Owned Properties. For the mowing Welsh Services was 14,000 and J&S Masonry was 13, 867. Dottie **motioned** to go with J&S for the 13,867. Sonny **second**. Joanne and Sonny made comments that they have done a good job. **All** were in favor. The snowplowing for town owned properties, the Board decided to go over the numbers next week at 6:00PM before the regular meeting so that they can make a decision.
- Vacation request from Rick Nugent and **All** were in favor.
- Joanne brought up that there was a request for the community Block party to raise more money and the Board decided to wait to make the decision.
- Wendy **motioned** to have a Special Town Meeting warrant held November 5, 2019, one to choose a moderator, article two regarding ordinance titled Municipal Volunteer Fire Department, article three is regarding to establish a group health insurance plan for eligible employees, article four will be to amend the Zoning Ordinance on Accessory Dwellings, article five to vote to enact an ordinance titled the Fee Schedule for the Code Enforcement Office, article six an amendment to the Limerick Budget Committee, and article seven another amendment to the Limerick Budget Committee Ordinance, and eight is to remove a paragraph in the Budget Committee Ordinance. Dottie **second**. Sonny asked if they were at

liberty to change the warrant, if something comes up and Dottie said that Judy would like to have it by the end of next week. **Four** were in favor, one did not raise their hand.

- The Fire department is asking to use Cintax for their supplies and because using them would be \$3000 and getting them through Plummer's was a little over \$1500 the answer from the Board was no.

WARRANT:

- Wendy **motioned** to approve the warrant as written. Dottie **second**. **All** were in favor.

ANNOUNCEMENTS:

- Wendy read the announcements.

HEARING OF CITIZENS:

- Steve Malmude got up and asked about what the Recreation Director would fall under for category of employee and the Board told him that he gets a stipend so he does not get other benefits of being an employee. Steve also asked why there has not been anything going on at the field, Dottie told him that it is in between sports. Steve also brought up the fact that there were no porta potties at the ballfield and the Board told him that there were two one that belonged to the Massabesic baseball team and the other should still be there but was probably taken by mistake and the Board will call and get it situated.
- Judy LePage got up and spoke about people calling the Town Clerk or Selectmen's Office about the water and sewer and there is nothing that we can do about it other than have them call the plant.

ADJOURN MEETING:

- Wendy **motioned** to adjourn. Dottie **second**. **All** were in favor.
- The Meeting was adjourned at 8:00PM.
