Hello Everyone,

The month of March 2023 was surely one of the most tragic and heartbreaking months for our brothers and sisters at the Edmonton Police Service with the senseless murders of Constables Travis Jordan and Brett Ryan. To compound their sorrow they are also mourning the untimely passing of two other serving members. Then, following the Regimental Funeral Services on March 27<sup>th</sup> for Constables Travis and Ryan we hear of a Quebec provincial police officer fatally stabbed while performing her duties in Louiseville, west of Trois-Rivieres, Que. The Surete du Quebec (SQ) confirmed the identity of the



officer as Sgt. Maureen Breau, who had been on the force for over 20 years.

March was certainly a sad time for, not only for the police services who these members worked for, but for the entire Police Community across Canada! I have included a few photographs of the funeral for the EPS members further on in this Newsletter.



At our Dinner / General Meeting we had Cpl. Sean Milne from the Edmonton Federal Serious & Organized Crime, Provincial Financial Crime Team give us an excellent and informative presentation on Fraud and Cybercrime. The following is how he summarized the presentation:

#### **Fraud Presentation Summary**

- <u>Slow down</u>! Scammers rely on tricking people into acting before they think.

- <u>No secrets!</u> Scammers want you to keep it secret or say you must keep it secret, i.e. a "gag order."
- Unsolicited e-mails and text messages should be treated with caution.
- Watch out for being asked to click a link or download a file.
- **Plus, Watch Out** for phone calls. If suspicious, hang up and call back using a verifiable number. A legitimate caller will understand.
- Do not send money, move money, or handle packages for anyone you haven't personally met and checked out.
- Watch out for unsolicited investment opportunities. See <u>www.checkfirst.ca</u>
- It is always illegal to be required to send money before you get money. Paying taxes/fees/insurance etc. before getting a loan or prize is a scam.
- Being asked to deal with gift cards, bitcoin, or cheques from strangers are sure signs of a scam.
- When in doubt, check it out. Ask around. A Google search with "scam" attached goes a long way. Share what you know and watch out for the people around you.




Rudy Kolodychuk enjoying himself above and the fellow who sent the note on the right to the CRA makes a particularly good point!

• Financial Update:

#### Dianne Lehman, Support Advocate:

- Dianne is still working on the mission statement which is very time consuming.
- A search is in place looking for a facility for Advocate training.
- Dianne is going to arrange a meeting with the Chaplains to get feedback and ideas on how information can be used for the benefit of all.

#### Jerry Plastow, Past President

- Jerry has received several donation requests one in particular for the International Women's Conference to be held in New Zealand, discussion came to the conclusion that we require more information from them. Jerry indicated more details would be required before a decision.
- In discussion with Dianne, Jerry learned that Legacy Place Society provided accommodation and assistance greater than 1,100 individual night stays per year to RCMP members and/or their families, in Alberta. There is a small fee for the use and can be used for a variety of reasons, as a safe house, somewhere to rest for whatever reason without question, again with no time limit. Jerry advised the Donation Committee agreed with his recommendation to donation of \$500.00 to the Edmonton facility. Dianne and Jerry will look at a tour for the Executive soon to enable us to have a better understanding of how they operate.

Jerry also advised the Donation Committee agreed we donate to Parkland Detachment \$500.00 for food for their RCMP 150 Celebration on the 27<sup>th</sup> May. The Committee also agreed to a \$500.00 donation to go towards some small gifts for the young people attending, with the gifts being age appropriate for the groups.

#### Elaine Schnepf, Director- Boost program:

• Elaine advised has been quite busy with two of our members passing and other members sustaining injuries, one of whom is our President who took a fall and broke his shoulder. Of course, there was much concern by the Executive about how it happened.

#### Bruce Allen, Director:

#### Eric Lafoy, Director:

- Eric informed the group there will be no Federal support for any RCMP 150 displays or presentations at detachments.
- We as a Division have funds for this purpose and will be supporting Parkland detachment as noted under Jerry Plastow above.

At any time, it is tremendously hard to process the falling of any fellow employees, colleague, friend or member. When many of these losses occur consecutively, it pushes our capacity. I am so proud of everyone in the RCMP, and in the first response profession, for carrying through these devastating days.

It is so important we continue to look forward, stay the course, and persevere. Although things can get so difficult, we must remember why we do what we do everyday and the reason for our service that helps us carry through the hardest of days. This month I will share with you some of our recent activity and a reminder of why we are all part of this profession – the ups and the downs that we go through together as an organization. Together, our employees and veterans are all a part of the fabric of the RCMP, and we will continue forward by sharing our successes through our ongoing support of each other.

## Passing of Alberta RCMP Constable Harvinder Singh Dhami

Most recently, and with great sadness, we most recently lost Constable Harvinder "Harvey" Singh Dhami of Strathcona County Detachment on April 10, 2023. Constable Dhami was involved in a motor vehicle accident while responding to assist members with a noise complaint. Despite the efforts of emergency responders and civilians present, Cst. Dhami succumbed to his injuries.



Cst. Dhami joined the RCMP in 2019 and was posted to Strathcona Municipal detachment. Harvey was known to be a team member who was compassionate, caring and very community oriented. Harvey is survived by his wife and his family in Ontario and British Columbia and support will be provided to his family during this difficult time.

Losing a member of our police service and a member of the community is incredibly difficult and the Alberta RCMP is very appreciative of the support by the community that has been extended to the family and the RCMP. Cst. Dhami's service and spirit with our organization will never be forgotten.

#### **Passing of Edmonton Police Service officers**

With the tragic passing of Edmonton Police Service Officers, Constable Travis Jordan and Constable Brett Ryan, March was a difficult month for everyone in first response and law enforcement. The loss of a fellow law enforcement officer is felt across all policing agencies. An event like that affects everyone in our organization and we did all we could to support Edmonton Police Service and partner agencies throughout the difficult days leading up to the regimental funeral.

Tragedies like these cause us to pause and really reflect on the work and sacrifices made by policing professionals every day. The duty and commitment of our members in their daily work alongside partners across Alberta was felt deeply during this tragic time and will extend throughout the months and years to come. There were so many acts of kindness and caring shown by Alberta RCMP employees in the days that have followed the deaths of Cst. Ryan and Cst. Jordan. I've seen respects paid in a number of ways, including a drive-past of the West Division EPS station and a charity hockey tournament. Our employees ensured family members of the fallen arriving in Edmonton were escorted throughout their arrival, and we have supported EPS as they organized a regimental funeral that saw thousands of officers, including over 400 in Red Serge, march through the streets of Edmonton. I am grateful each day for everything that our employees do for the safety and well-being of Albertans around the clock. Being able to march in the regimental funeral procession and be present to honour the service and lives of the fallen offices was significant for us.

March was also the anniversary of the tragedy at Mayerthorpe when we lost our own, Cst. Anthony Gordon, Cst. Leo Johnston, Cst. Peter Schiemann, and Cst. Brock Myrol. Recognizing the service of all our fallen colleagues is of the utmost importance to the RCMP, and our thoughts and support are always with the families of our fallen. We stand together, with our policing partners and all our first response family, as we mourn the loss of those who have fallen in the line of duty in their courage and valor. Their sacrifice and their service will never be forgotten.

#### **Community work**

It is important during all times, even difficult ones, that we stay connected with our citizens. Community work is an important part of our service effort and engagement with our communities. Recently, I was happy to be able to join more than 600 athletes in Sherwood Park last month at the Special Olympics Alberta Winter Games. I was honoured to be able to present at the closing awards ceremony and then

get acquainted with the local winners.



In Leduc, Constable Cheri-Lee Smith helps maintain the partnership between Leduc RCMP and the Leduc Public Library with the R.E.A.D. with the RCMP Literacy Program to foster a love of reading and help build the relationship between policing and the local community through literacy education.

In Coaldale, detachment members joined the Alberta Sheriffs and Lethbridge first responders for a game of hockey with the Lethbridge Lightning Senior AA team in support of the Jack Ady Cancer Centre, raising over \$4500.



It's important to stay connected and engaged whenever and however we can. Serving the people of Alberta is foremost for safety and well-being and also for the important relationships we are building along the way. I look forward to sharing more of our community work and achievements to come.
