

**BOARD OF SELECTMEN**

**October 21, 2019**

**PUBLIC HEARING ON NOVEMBER WARRANT ARTICLES FROM 6:00PM TO 7:30PM**

- Dottie motioned that we accept the Municipal Building Access Policy that Wendy wrote up. Sonny **second**. Gil made the comment that we should have something similar for the Brick Town Hall. Dottie **amended** her motion to say accept the Municipal Building Access Policy but to include the Fire Department on here, which was supposed to be on here but we missed it. Gil **second**. **All** were in favor.
- The Board discussed the Brick Town Hall doors and how we have the money to get them replaced. Joanne **motioned** to accept the quotes from Door Systems Corporation for a total of 3587. Wendy **second**. **All** were in favor.

- Wendy brought up that she had gotten the salary survey ready for everyone to look over.
