### **Executive Summary:**

The purpose of this report is to provide the Commission with an overview of the Standing Committee item(s) discussed during its meeting held Tuesday, June 20, 2023, meeting number SC-05-2023.

### 1. Inspections

During the meeting of the Standing Committee, members discussed taxicab and industry inspection requirements, and moved and carried Item 3 of Other Business to direct staff to undertake a review of the current by-law and report back to the Taxi Commission:

Moved by Commissioner Fraser Seconded by Commissioner Chapelle

**That** staff be directed to undertake a review of the current by-law regulations respecting Inspections and Industry requirements and report back to the Commission in Q3 2023.

### **Review Findings:**

As directed by the Standing Committee, a complete review of the current by-law requirements outlining taxicab inspections are detailed below as a clause-by-clause report:

#### **RIGHT OF INSPECTION**

The Plateholder of every vehicle in respect of which a Taxi Plate has been issued under this By-Law shall, when required, submit his/her/their vehicle for examination by the Licence Inspector or a police officer, and no Plateholder or Driver shall, at any time, prevent or hinder the said Licence Inspector or police officer from entering his/her/their garage or other premises or buildings for the purpose of inspecting same, provided that the right of inspection does not include a dwelling unit.

### RENEWAL, REFUSAL OR SUSPENSION OF LICENCE, BADGE OR PLATE

- **51(1)** The Licence Inspector is authorized to:
  - (a) inspect each vehicle operated, provided or used as a Taxicab;
  - (b) require that each vehicle that is operated, provided or used as a Taxicab be submitted for inspection;
  - (c) ensure that each Plateholder produces his/her/their vehicle for inspection at the time; and
  - (d) inspect as much of a house, place, or premises as is used for the carrying on of a Taxicab brokerage business.
- **51(2)** The inspection of vehicles operated, provided, or used as Taxicabs may include an inspection by a motor mechanic.
- **51(3)** No person shall obstruct, hinder, or otherwise interfere with the aforesaid inspection.

Additionally, the Commission did move and carry the following amendments and adoptions of the following to the by-law:

Whereas pursuant to By-Law #2, Section 38, the following sub-section be drafted and adopted by the Commission as part of By-Law #2, Section 38:

- **10.** That any appointed and/or elected active member of the Commission Executive, by ex officio, shall have:
  - a. The right to appoint and/or authorise any Person or Agent to act on the Commissions behalf, and that such Person or Agent possesses sufficient training and qualification to perform said task.
- 11. That such Person or Agent who has been duly appointed and/or authorised by the Commission Executive, shall have right by virtue of, the same authorities and abilities equal to that of the License Inspector.

### **Conclusions:**

Based upon the review findings of the current by-law respecting inspections and the right of the Commission thereof, the Commission and/or their duly appointed Agents are within their scope to, at their discretion:

1. at anytime may conduct an inspection of a taxicab;

- 2. that such inspection(s) can occur at any frequency, and;
- 3. that any person who obstructs, hinders, or otherwise interferes with an inspection is subject to enforcement action.

Additionally, it should be noted that the Kingston Area Taxi Commission has appointed Paladin Mobile Patrol, and their duly licensed staff, to conduct inspections on vehicles operating as taxicabs and is authorised to do such per Bylaw Number 2, 38(11).

#### **Recommendations:**
