**Membership** in WODL is available to any not-for-profit theatre group in the WODL area which has been in operation for a period of at least one year, has a board of directors and has presented at least two plays. Currently the annual Membership Fees of \$200.00 are payable by the 1st of October each year. Applications for membership will be considered at any time. Once your application form for membership has been received and reviewed, you will receive a notification pertaining to acceptance or denial. You must be a member group before applying for adjudications.

**Adjudications:** If possible, new members should apply for adjudication before the deadline, which is mid-September. This applies to adjudications In-Festival (willing to take your show to another town) or Out-of-Festival (eligible for appropriate awards). An *Application for Adjudication* form should be downloaded from the WODL website and submitted to the adjudications chair. [adjudications@wodl.on.ca](mailto:adjudications@wodl.on.ca) While every effort will be made to accommodate applications for adjudication received after this deadline and within the period of adjudications, adjudication might not be possible.
