EC911 Report:

Councillors Nichols and Nelner attended the November 29th General meeting of EC911. They reported on the 2018 budget.

- Operating budget will remain at \$6.40/capita for 2018.
- EC911 are hoping to increase their membership.
- They continue to promote their "work alone" service to help member communities become compliant with Occupational Health and Safety guidelines and regulations.
- There continues to be radio issues. It will be a priority to resolve these issues.
- Other competitor service providers have been meeting in the area communities.

Water Reserve:
