November 25, 2019

CALL TO ORDER: Sonny opened the meeting with the pledge at 7:05PM.

- Wendy **motioned** to approve the minutes for November 18. Dottie **second**. **All** were in favor.

- Roy Bagley, President of the Sokokis Lake Association, talked about the dam and how he would like the Board to honor the vote to allow the association to put in a machine to lift and lower the boards and to also honor the agreement to let the association manage the level of the lake. Roy said that he had talked to Bob Richardson about it and that Bob would not go further without direction from the Chairman or the Board. Roy also went on to say that it would be a temporary structure because it would only be up for the summer months and would be taken out before the 1st day of the 7th month, he also told the Board that it was determined that they do not need a permit for this machine. Sonny told him that in speaking with Bob Richardson himself Bob was not in favor of putting this machine in but Sonny told him that the Board/ himself would look further into it and get back to him.

- Dottie **motioned** to approve the warrant articles for the Special Town Meeting on December 9th. Gil **second**. **All** were in favor.

- Wendy also brought up the Budget Process and needing to continue on with that and the Board set up a workshop for 6:00PM on December 2nd to finish going through it.

- Dottie read the announcements.

HEARING OF THE CITIZENS:

- Steve McLean got up and talked about the Fire Department and how the volunteers are now being called support staff and it is degrading. He also talked about how something needs to be done with the Fire Department and it needs to be figured out.
