December 23, 2019

CALL TO ORDER: Sonny opened the meeting with the pledge at 7:05PM.

- Wendy **motioned** to approve the minutes for December 16. Dottie **second**. **All** were in favor.

DEPARTMENT REPORTS:

- Joe Parsons, Recreation Director, came in and talked about his three to five year plan with turning the cement slab at the ballfield into a multisport complex. He also talked to the Board about his budget and how he went off of the budget from last year. Dottie **motioned** to put \$13,383 on the warrant for the Rec Department. Joanne **second**. **All** were in favor.

- Dottie **motioned** to recommend to present on the warrant \$54,931 to the Treasurer. Gil **second**. **All** were in favor. For the Tax Collector/ Town Clerk, Joanne **motioned** to recommend \$88,922 for the warrant. Gil **second**. **All** were in favor. Elections, Dottie **motioned** to recommend \$11,178 for the warrant. Joanne **second**. **All** were in favor. Code Enforcement, Dottie **motioned** to put \$63,875 on the warrant. Gil **second**. **All** were in favor. Planning Board, Gil **motioned** to recommend \$10,736 for the warrant. Dottie **second**. **All** were in favor. Roads, Dottie **motioned** to recommend \$200,000. Gil **second**. Three were in favor, Joanne and Gil did not raise their hands. Paving, Dottie **motioned** to recommend \$280,000 for the warrant. Sonny **second**. **All** were in favor. Hazardous Trees, Dottie **motioned** to recommend \$6,000 to the warrant. Sonny **second**. **All** were in favor. Transfer Station, Dottie **motioned** to recommend \$115,768. Sonny **second**. **All** were in favor. Door to Door, Dottie **motioned** to recommend \$120,000. Sonny **second**. **All** were in favor. Tipping Fees, Dottie **motioned** to recommend \$116,250 to the warrant. Sonny **second**. **All** were in favor. Library, Dottie **motioned** to recommend \$73,419 to the warrant. Sonny **second**. **All** were in favor.
- Gil brought up Neal Courtney and how the meeting that they had with him was the one free of charge and that they should look over the sections that he had written up and see which ones they want done for the Fire Department Sonny brought up that it would not be plausible at this point in time and it will be better if they wait.
