Introducing Our Judges

KEITH BROWN

“My family bought their first Pekingese in 1966; this dog became the foundation breeding bitch for my parents’ kennel. I started showing when I was eight years old and have still some of the top winning Pekingese in New Zealand today.

I have bred and owned over 80 Champion Pekingese, 15 Grand Champion Pekingese, and I am the breeder of the only Supreme Champion Pekingese in New Zealand. I have also bred and owned 70 Champion American Cocker Spaniels and 17 Grand Champion American Cockers. My other breeds are Miniature Schnauzers and Afghan Hounds, of which there has also been Best in Show winning dogs. We are also the owners of “Jack”, the Kerry Blue Terrier that was the #1 dog all-breeds in Canada in 2016 as well as the #1 all-breeds dog in Australia in 2015. Parkavon Kennels is considered one of New Zealand’s foremost kennels with over 850 all-breed Best in Shows to our credit.

I started judging when I was 18 years old and became an all-breeds judge in 2005. I have judged not only in New Zealand but all states of Australia, United States, South Africa, Singapore and Japan, Ireland, China, Indonesia, India, and the Philippines.

I am a Life Member of the Canterbury Toy Dog Society and Canterbury Kennel Association. I am also an Executive Councilor of Dogs in New Zealand, our national control body. “ *Mr. Brown is also judging the Mid-West Cocker Spaniel Club of Canada Specialty, the Toy Dog Club of Alberta Specialty, the Schipperke Club of Canada National Specialty, and the NACA All-Terrier Show at this event.*

GAIL CARROLL

“I have been playing with dogs for much of my adult life. During this time I have trained and handled a succession of Siberian Huskies and one Tibetan Terrier to a variety of Canadian and American titles in conformation, obedience, and rally.

I am fortunate to have owned two history-making Siberians. Ch. OTCh. Watasoggin’s Suntar of Laska was the first Canadian Siberian to earn both a breed Championship and a Utility title in Obedience. MBIS,MBISS,CanGCh./Am.Ch. Oshvah’s Rooo The Day, CanCDX, RE, Am.CD, RN, known as Daisy, was the first Siberian to earn Canada’s Grand Champion title and in 2013 became the first Siberian to be awarded Canada’s then brand new Grand Champion Excellent title.

I have been judging obedience trials for close to 30 years, and more recently, rally trials, both in Canada and in the US. I am a long-time member of the Canadian Association of Obedience Trial Judges. I am a life member of the Canadian Kennel Club and have served for many years as Manitoba’s representative on the CKC Obedience Council.

I currently have only one Siberian Husky, CanCh/AmGCh. Oshvah’s Ruby Red Dress, PCD,RN and, just for fun, I am training a Golden Retriever which belongs to a friend.

RAYMOND V. FILBURN, JR

Ray is no stranger to dog shows. He exhibited his first Italian Greyhound at the age of 14. He has exhibited and bred Rayridge Italian Greyhounds for 50+ years. He believes that living with his chosen breed has developed his judging eye. He feels privileged to share his life and home with live porcelains; with their artistic lines and intrinsic beauty. During this time he has had great success in the show ring and whelping box. His dogs have won specialties, groups and Best in Show awards. Ray's show ring successes do not overshadow those of a dedicated breeder. Several of his dogs have been top producers; having bred some 100 Champions that carry the Rayridge banner.

Ray is a lifetime member of the Italian Greyhound Club of America, Inc, and has held many offices with this club. His devotion to the breed and Club earned him the Gaines Good Sportsmanship Award. He has been privileged to judge the National Specialty several times. Believing education is important, Ray was instrumental in establishing the judges and breeder's educational program for the IGCA, long before the American Kennel Club mandated Clubs to have educational events.

Ray is also a member of the North Shore Kennel Club, and the Poodle Club of Massachusetts. He is also a founding and charter member of the Town and Country Toy Dog Club. Ray has been show secretary for the South Shore Kennel Club and has chaired many independent specialties.

Ray's judging career began in 1979. He is currently approved by the AKC to judge all Toys, Herding, Hounds and Non-Sporting breeds, as well as Junior Showmanship. Ray has judged in all 50 States of the USA. He has travelled to the far reaches of the world as well to judge many international shows; such as those in Australia, Canada, Columbia, Indonesia, Japan, Hong Kong, Ireland, New Zealand and many others. When not out on assignment Ray can be found spending time with family and friends, travelling for pleasure or on the tennis courts.

VALERIE HANSEN

"Most of my purebred dog life has been in Afghan Hounds. I bought my first Afghan from Miles & Greta Phillips of Kophi Kennels fame back in 1969 and subsequent to that I bought two boys from Glorvina Schwartz of Sandina Kennels in New York. Those two boys were the foundation of my breeding program (Khardhani Afghans). Every single dog I kept from my breeding program were Group winning or placing dogs, and two of these became Best in Show winners. After my last Affie was retired (unfortunately deceased in 2014) I acquired a Chinese Crested boy from Wind Chinese Cresteds. He and his Afghan were best buddies.

I began my judging career back in 1997 when I wrote my first exam. I have been fortunate to judge several Afghan and Sighthound Specialties including Canada and the U.S and have also judged in Bogota, Columbia.

I am currently President of the Afghan Hound Club of Canada (yes, still my heart breed) – a total of three terms. In the past, I've been President, Director and Education Chair of the Southern Alberta Canine Judges Association.

In addition, I am still trying to be a contract working person, employed in the oil and gas industry in Calgary, Alberta, and have been happily married for 27 1/2 years to my very patient husband Marshall."

STEPHANIE HEDGEPATH

"My involvement with the world of showing dogs began in 1968 with the purchase of my first show dog, a German Shepherd dog. In the mid-seventies I began breeding and showing Pembroke Welsh Corgis under the Jimanie prefix and have finished a Championship on a Pembroke Welsh Corgi on the average of one a year for the last 40+ years – almost all were breeder/owner handled to their titles. In 2010 I formed a loose partnership with two long-time friends, Denise Scott and Linda Stoddard, and we now breed and show under the Trifecta prefix.

I am a breeder/owner/handler and still breed and occasionally show. Over the years I have owned and shown dogs mostly from the Herding and Sporting Groups plus a few Toy breeds. I started out showing dogs from the Herding Group, but as a hunter, I always had a "bird dog" and thus also showed Brittanys, Pointers, Golden Retrievers and Irish Setters over the years. I have finished dogs in several other breeds from the Sporting and Toy groups.

I started my judging career in 1988 with AKC approval to judge German Shepherds, Cardigan and Pembroke Welsh Corgis. I judge the Herding, Sporting and Toy groups and several of the Non-Sporting breeds as well. I have been fortunate enough to have judged dogs all over the US and Canada and also in Finland, Norway, Sweden, Jamaica, New Zealand, Australia, Ireland, China, the Philippines and the United Kingdom. In 2011 I was accorded the supreme honor of being asked to judge the Welsh Corgi League show in the UK and in previous years both the Cardigan and Pembroke Nationals in the US. I have also had the honor of having judged many National and Regional Specialties for breeds I did not breed, own or show from the Sporting, Herding and Toy groups throughout the years, an assignment I always enjoy!

Some of the highlights of my judging career have been judging at Westminster Kennel Club in 2006, doing the Herding Group at the Rose City Classic in Portland which was shown on Animal Planet and the national specialties for Clumber Spaniels, Field spaniels, Australian Shepherds, Bouviers (Canada) and the Top Twenty competition for the Golden Retriever Club of America as well as both of the Corgi national specialties and the Welsh Corgi League show mentioned above.

I make my living as an artist, mostly through the design of counted cross-stitch and needlepoint but also through paintings and sculpture as well as jewelry. I have recently begun authoring and producing DVD's on the canine, mostly dealing with structure and movement.

Last, but certainly not least, I've been married to Jim Hedgepath since 1972 and am the mother of two and the grandmother of four." *Mrs. Hedgepath is also judging the Pembroke Welsh Corgi Club of Canada National Specialty at this show.*

DAVID M. KELLAND

After finishing graduate school in Italy and finding both stable work in his profession as an architect and a stable home – almost the first thing David did was buy a Labrador Retriever puppy, which had been a life-long wish.

Now – many years later – and a life member of the Canadian kennel Club, David starting showing in 1983. Over the years he has not only had Labradors but Pekingese and Miniature Wire-Haired Dachshunds. His interest in judging came about as a result of a growing understanding of the extreme differences between Labradors and Pekingese – structurally, functionally, and temperamentally.

The Pekingese prefix Michaelmas was registered in 1985, in partnership with Gary Tucker, after acquiring an outstanding bitch Pekingese puppy from England. They have since gone on to produce multi Bests in Show winners. They continue to breed and show with the sole goal of being able to make some small contribution to the health, soundness and type of the Pekingese breed.

David started judging in 2004 and is fully licensed to judge the Sporting, Working and Toy Groups and is currently on permit for breeds in the Non-Sporting Group.

David has judged in England and extensively throughout Canada and the United States and is honored to have been invited to judge for the Northern Alberta Canine Association.

SHAWN KELLY

"Hi everyone. I was introduced to the world of dogs in 1999 when my wife Patty and I got our first Golden Retriever. We began obedience classes with Tucker and it wasn't long before my competitive nature took over. Upon retiring from competitive fast pitch softball in 2000, I began competing in obedience trials and by 2008 Tucker and I had earned Rally Excellent, Agility, Canine Good Neighbor, multiple HIT's and our coveted MOTCh title.

In 2000, along came Freelins Java Jolt, whose natural retrieving abilities led me to pursue Junior Hunt and Working Certificate titles, in addition to her Obedience, Rally, Agility, and show titles.

By 2006 my interest in both obedience and rally obedience had peaked, and being a "rules person" I decided to pursue judging. I successfully obtained my rally license in 2009 and in 2011 earned my obedience credentials. I enjoy competing and judging equally, and enjoy meeting new people at every venue.

I was born and raised in Halifax, NS, grew up with 5 brothers and sisters, graduated from St. Mary's University and have been employed by the Federal Government for more than 27 years. Please see CKC rule books for specific class descriptions. These rules may be viewed on the CKC website (<https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-Regulations/Conformation-Show-Rules-and-Regulations.aspx>). It is the responsibility of the exhibitor to be familiar with the Conformation, Obedience & Rally rules as set out by the Canadian Kennel Club

CONFORMATION

The following CKC conformation classes (divided by sex) will be offered:

Junior Puppy: for dogs 6 mths of age but under 9 mths of age.

Senior Puppy: for dogs 9 mths of age but under 12 mths of age

12-18 Months: for dogs 12 mths of age and under 18 mths of age

Canadian Bred: for dogs born in Canada; champions in any country excluded.

Bred by Exhibitor: for dogs owned and handled in the ring by the breeder.

Open: for all dogs.

Specials Only: dogs which are registered individually in the records of the Canadian Kennel Club and have attained championship status may be entered in the 'Specials Only' class. Exhibition Only: for all dogs over 6 mths of age and eligible for registration with the CKC (non-competitive class).

Veterans: offered Saturday only. Veterans will be divided Males and Females with a Best Veteran in Breed judged for each. The Best Veteran in Breed winner will go on to Best Veteran in Group and Best Veteran in Show. Dogs must be 7 years or older on the day of the show.

Baby Puppy (3-6 Mths): offered Friday, Saturday, Sunday only. For dogs 3 mths of age & under 6 mths of age – dogs will compete in this unofficial class for Best Male/Best Female, Best Baby Puppy in Breed, Group & Show. They do not compete for Winners.

Altered: offered Sunday only - dogs for the altered classes shall be limited to dogs over 6 months of age which have been spayed or neutered by veterinary procedure. Altered dogs must be entered in a Regular Class or for Exhibition only to be eligible to compete.

OBEDIENCE

Pre-Novice: for any pure bred dog that has not earned the title PCD (Pre Companion Dog) title in Canada. Dogs in this class may be handled by the owner or any other person. A dog may be entered in this class that has not earned the title of CD in Canada or US.

Novice A: for any purebred dog that has not won the title of CD. Only one dog may be entered in this class by any one exhibitor. A dog which has won a comparable degree in any foreign country is not eligible for this class.

Novice B: for any purebred dog that has not won the title of CD in CANADA. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the 'sit' and 'down' exercise. A dog which has won a comparable degree in any foreign country is eligible for this class.

Novice C: for any purebred dog that has gained a CD, CDX, UD or any other advanced title and exercises will be performed and judged as described in the official Novice classes. Scores earned in Novice C are not eligible for High in Trial. This is an elective class and offered for those people who feel the dog requires ring experience. Dogs may be entered in Novice C class in addition to any of the Official Classes or Unofficial classes.

Novice Intermediate: For any dog that has earned a CD or higher obedience title. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are NOT eligible for High in Trial.

Open HA or 18A: for any purebred dog that has won the title of CD but has not won the title of CDX. The handler of any dog in this class must be the owner, co-owner or immediate member of their family. Only one dog may be entered in this class by any one exhibitor and must be handled by the same person for all exercise. Any person who has trained or exhibited a dog that has earned a UD may not handle a dog in these classes.

Open HB or HB: for any purebred dog that has won the title of CD, CDX or UD in CANADA. Dogs in this class may be handled by any person. A person may enter or handle more than one dog in these classes. A dog which has won a comparable degree in any foreign country is eligible for this class. A dog eligible for UD is also eligible for entry in this class at the same trial.

Utility A: for any purebred dog that has won the title of CDX in CANADA. Handlers may enter more than one dog in this class, but each dog must have a separate handler for the 'group examination' exercise.

Utility B: for any purebred dog and handler where the dog has achieved a CDEX and a UD title and for dogs and handlers where the handler has put a MOTCH title on any dog.

RALLY

Rally Novice A: Dogs entered in this class may not have won a CKC Rally Novice title or any CKC Novice Obedience title.

Rally Novice B: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. No dog may be entered in Rally Novice A and Rally Novice B at any one trial.

Rally Intermediate: For dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class indefinitely. Dog handled by owner or any other person.

Rally Advanced A: For dogs that have won the Rally Novice title but have not won the Rally Advanced title or any CKC Novice Obedience title.

Rally Advanced B: For dogs that have won the Rally Novice title no dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

Rally Excellent A: for dogs that have won the Rally Advanced title but have not won the Rally Excellent title or any CKC Novice Obedience title.

Rally Excellent B: for dogs that have won the Rally Advanced title. No dog may be entered in the Rally Excellent A and Rally Excellent B class at the same show.

Rally Master: for dogs that have earned their RE title. Dogs who have completed their RM title may compete in this class indefinitely. The owner or any other person may handle a dog in this class.

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules" and that I am (we are) familiar with their content. I (we) agree that the Northern Alberta Canine Association has the right to refuse this entry for just cause, which the Club shall deem to be sufficient. In consideration of the acceptance of entries made in these all-breed shows, obedience trials, agility trials or any of the associated Specialties, and of the holding of these shows and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Northern Alberta Canine Association and associated Specialty Clubs, their members, directors, governors, officers, agents, superintendents, or show secretaries, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these shows and trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

RULES GOVERNING THESE SHOWS

1. Dogs must be kept on a leash at all times on the show grounds or within the show building.
2. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of these shows and trials, which will be governed by CKC rules.
3. ANYONE PARKING IN THE FIRE LANES OR OTHER AREAS DESIGNATED AS "OFF LIMITS" WILL BE REMOVED FROM THE SHOW.
4. All recreational units must have buckets underneath for their drains. Those discharging of any water on the grounds will be removed by order of the health department and subject to a fine.
5. A judge officiating at this show held under CKC rules shall not be subjected to any indignities of any kind during the progress of the show. (4.7.1)
6. A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent (5.1.6)
7. There is to be NO SMOKING in the large show tent, nor entrances to it, and NO SMOKING is allowed in the show building.
8. Dogs must be on the show grounds 1 hour prior to judging of their breed.
9. All vehicles are left on the show grounds at your own risk. No security is provided.
10. **No abuse of parking personnel, NACA members or volunteers will be tolerated!!**
11. RV's will not be allowed to travel on the show grounds when judging is occurring. Under special circumstances (in case of emergency) the show superintendent will stop the show and parking personnel will assist in the safe removal of vehicle.

Section 15.1.12

In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- (a) earn at least ten (10) championship points under at least three different judges and.
- (b) be individually registered in the records of the CKC or have an *Event Registration Number* or a *Miscellaneous Certification Number*.
- (c) have earned at least one 2-point win either at the breed or group level.
