Mayor DeVloo welcomed Mrs. Tkach to the meeting.

Mrs. Tkach updated Mayor and Council on the history of the Advisory Council. She was appointed to the Council in October and has worked within the healthcare system for the past forty five years.

There are twelve Health Advisory Councils within the Province, two Provincial Advisory Councils (focusing on Cancer and Addiction and Mental Health) and a Wisdom Council (focusing on Indigenous Health Priorities).

The Council provides feedback to Alberta Health Services on healthcare service and programs and community priorities.

The committee members are volunteers and are comprised of general public, community leaders, past health care providers and members of local F.C.S.S; and are a diverse group of individuals.

The Council shares information with Alberta Health Services on community positives, what is working well and where there needs to be improvements. Currently they are working on a fifteen year long range plan.

A discussion occurred around the dynamics of Rural Albertans physical and mental health and the distances that they are required to travel for tests and services.

The Council is focusing on prevention monitoring, senior care, addiction and mental health, long term care and supportive living, and doctor retention and recruitment.

The Council represents all the communities and hospitals in the area, whether they are Alberta Health Services or Covenant Health. As she acts as a liason between Alberta Health Services and the communities, she can present community based ideas, suggestions and concerns.

Mrs. Tkach's appointment is a three year commitment and she is available to discuss community concerns and such at anytime.

Mayor DeVloo and Council thanked Mrs. Tkach for coming to the meeting and updating them on the happenings of the David Thompson Health Advisory Council.
