

Skincare/Laser Treatment Specialist Position

We are looking for an experienced, professional and reliable **Skin Care/Laser Treatment Specialist** to perform facial and body laser treatments. The **Skin Care/Laser Treatment Specialist** will provide laser treatments and consultation to clients to assess their eligibility, current health condition and medical history to help them make informed decisions prior to their laser session. You will consult with clients to explain treatments and services, make informed recommendations, assist them to select appropriate treatments, and ensure their pre and post treatment care.

The Skin Care/Laser Treatment Specialist will ensure treatments start and end on time. You will maintain knowledge to promote and sell laser treatments and skin care services. You will ensure work equipment is sanitized and treat clients in a courteous and empathetic manner.

To ensure success, you should meet revenue goals, ensure client retention and build a solid client base. Ideal candidates has good customer service skills and will be empathetic, patient, reliable, caring, ethical and professional, and have the ability to make others feel good about themselves.

The successful candidate is expected to contribute positively to the implementation of Nani's Esthetics Vision and Mission, operate in a collaborative team setting, and maintain high productivity levels, strong work ethics and quality of work.

5. Advising clients on skin care, and recommending suitable treatments and home care regimens based on their needs and concerns
6. Engaging and conversing with clients during sessions on topics relating to their interests.
7. Maintaining strong product knowledge to promote and sell laser and skin care treatments, services, and products.
8. Adhering to esthetics policies pertaining to chemical usage, and cleaning, sanitizing and maintenance of equipment.
9. Caring for linens and replacing them between sessions.
10. Ceasing treatment and informing supervisor in the event of inappropriate guest behavior.

- **Evidence that you meet the requirements of the job offer and your work experience and employment history, such as:**
 1. **Letters from current and past employers specifying your position, duties, earnings;**
 2. **Payslips/ Payroll bank statements.**
 3. **Evidence of contributions to social insurance regimes working as Beautician in a Salon (eg. SSS); proof of payroll deposits;**
- **Proof of education:** Copies of related/relevant education certificates as esthetician/beautician, school transcripts, School Grades, diplomas, degrees, TESDA Certificates as Beautician.
