Provincial/Federal Funding: Lisa Holmes, AUMA President contacted Council

regarding the Building Canada Fund and New Federal Infrastructure Fund. The Building Canada Fund still had a \$700 million envelope to fund municipal projects – that will now go to provincially owned projects and the province's deficit. Minister Mason has agreed to meet during the Mayor's Caucus on March 7 to discuss this. Minister Mason will also speak to the allocation of the remaining Phase 1 funding of the New Federal Infrastructure Fund (\$12 billion over the next 5 years).

The outstanding invoice is for work in 2015 that was not completed to the satisfaction of the Fire Department

and the Town.
