TERMS AND CONDITIONS

The undersigned business (or individual), hereinafter called LEASEE, does hereby make application to participate as a vendor at the Northern Alberta Canine Association dog show being held at the Ottewell Curling Rink 4205-102 Avenue, Edmonton, AB, on May 29, 30, 31st, and June 1st, 2020. Vendor space rental is for four (4) days. No one-day rental space is available. In consideration of the acceptance of the reservation LEASEE hereby agrees to the following conditions:

- **Deadline** - Contracts must be received with payment in full no later than the closing date of entries for the show. Potential vendors are strongly encouraged to submit application and payment well in advance of the deadline. Applications received after the deadline require payment by CASH ONLY.
- **Refunds** – Fees will be refunded (1) in the event a LEASEE's application is rejected, or (2) in the event a LEASEE notifies the Northern Alberta Canine Association in writing on or before show closing that they will be unable to attend. After show closing, fees may be refunded at the sole discretion of the Northern Alberta Canine Association.
- **Resale License** – Any licensing requirements are the sole responsibility of the LEASEE.
- **Assignment Prohibited:** LEASEE will not assign, sublet, or apportion the whole or any part of the space allotted to any individual, partnership, corporation, company, firm, or entity, without the prior written consent of the Northern Alberta Canine Association Show Chairman.
- **Dogs** – Only dogs entered in the Northern Alberta Canine Association Show are permitted on the show grounds as per CKC rules.
- **Indemnification** - Northern Alberta Canine Association assumes no liability for bodily injury or property damage incurred by the LEASEE, its employees, or agents while on the Ottewell Curling Rink grounds. LEASEE shall defend, indemnify and hold harmless Northern Alberta Canine Association its volunteers, designated agents, employees, and/or contractors, from and against any and all claims, losses, damages, injuries, penalties, governmental charges or fines in any amount arising out of, or caused by the LEASEE's use of the premises, the conduct of the LEASEE's business or from any activity or work done, permitted or suffered by any vendor in or around the premises, including but not limited to the installation, operation, maintenance or removal of merchandise.
- **Setup and Security** – The show ground will be open for set up on Thursday May 28 from 12:00 Noon until 10:00 PM. ***Absolutely no vehicles are allowed on the show grounds during show hours from Friday morning until the end of the show on Monday evening. It is the responsibility of the LEASEE to ensure their booth and set up is secure from theft, damage or loss for the duration of time on the grounds.***
- **Clean up** – LEASEE is responsible for cleaning and maintaining their assigned booth space for the duration of the show and for cleaning and clearing their area at the conclusion of the event.

The Northern Alberta Canine Association reserves the right to reject any application and to demand the release of any rented booth space at any time before or during the show for failure to meet any of the requirements contained herein, for violating any applicable Provincial, City and/or County laws and/or regulations, and/or for display conduct that is dangerous destructive, or in any way prejudicial to the welfare of the sport of purebred dogs.

This is a binding contract when accepted by Northern Alberta Canine Association. Acceptance is reflected by payment for Booth Space.

Contracts received without payment will be deemed incomplete and will not be processed.
