A Brief History of the Robson Family

The Robson family is most known for their leather work in Oshawa. James Robson purchased Bartlett Tannery in 1865. After a fire forced him to relocate factories in Oshawa, he reopened the company as Robson Tannery (although it was mainly known as Robson Leather). Robson Leather quickly established itself as one of Canada's foremost tanneries, especially during both world wars. During the First World War 70% of all upper leather (that is all leather on a boot above the sole) worn by the Canadian Expeditionary Force. During the Second World War, they produced 60% of all upper leather worn by the Canadian Armed Forces. It was during World War Two that Charles Sr. passed away, and Charles Robson (James Robson's grandson) took control of the company. He would run the company with his brother until 1963 when the company merged with James Lang Leather Company to form Robson-Lang Leather Limited. Unfortunately, this business venture would not last long as the company closed its doors in Oshawa in 1977 after a long, drawn-out strike.

Charles Robson is also known for his estate, affectionately called Cluaran Farm. The estate was purchased by Charles and his wife, Mabel, from her family in 1944 for \$6500. The house, which underwent extensive construction by Charles and Mabel, stayed in the Robson family until it was acquired by the Ministry of Transportation. It was then destroyed to make room for the 407 extension.
