

Online Payments Available

Members of IUPAT District Council 39 have the option to pay **monthly Union dues** and **Medavie Blue Cross self-pays** through online banking with the following banks:

- Credit Union Atlantic, Scotia Bank, TD Canada Trust, RBC, BMO and CIBC.
1. Sign-in to your online banking system.
 2. Select the account you'd like to make the payment from and enter the amount you'd like to send.
 3. Select "add payee" and create *or* use the search feature to find "**IUPAT DISTRICT COUNCIL 39**".
 4. Enter your **9 digit account number** (See **Member ID Number** shown below, this is your account no.)
 5. Submit, the payment has been sent.
