



# **BACKSTAGE**

#### Dressing Room #1 - Shaw

Accommodates approximately 20 people: 1 shower, 3 sinks, 2 toilets, 2 rolling costume racks.

#### Dressing Room #2 - Shakespeare

Accommodates approximately 20 people: 1 shower, 3 sinks, 2 toilets, 2 rolling costume racks.

#### Green Room - W. O. Mitchell

Accommodates approximately 20 people: microwave, bar fridge, television monitor, tables, chairs, couches and dishwasher.

There is a stackable washer and dryer in the Theatre.

#### **STAFFING**

- The number of personnel required will be determined by the Technical Director to
  ensure your event's technical needs are met. Unless otherwise arranged, we will use up
  to 3 technicians for your event. If you require additional crew (spotlight operators,
  loaders, extra stagehands, etc.), there will be additional charges applied. If you have
  questions regarding your technical requirements, please contact our Technical Director.
- Theatre staff are provided a minimum of a 30-minute break within every 5 hours worked, as per Alberta Employment Standards.

### **USE OF HAZARDOUS MATERIALS**

All pyrotechnics require a licensed pyro-technician who must be approved prior to the event by the Technical Director.

Vic Juba Community Theatre does not allow any open flame anywhere on the premises.

#### **Substance Regulations**

Government of Canada legislation requires that the use of "controlled" products in our theatres shall comply with the rules under WHMIS (Workplace Hazardous Materials Information System). Controlled products include:

- Compressed Gas
- Flammable and Combustible Material
- Oxidizing Material
- Poisonous and Infectious Material
- Corrosive Material
- Dangerously Reactive Material

#### WHMIS regulations require that:

- a) Anyone using a controlled product in the workplace must be informed as to its safe storage, handling, use and disposal.
  - b) All containers of controlled products must have warning labels attached that meet regulation requirements.
  - c)A MSDS (Material Safety Data Sheet) for any controlled product must be available and be maintained in the immediate work area.

Some substances such as explosives, radioactive materials, and tobacco are covered under separate regulations. Smoking in our Theatre, for example, is restricted under our Civic Bylaws to designated areas only.
