- a) Follow up on actions from previous meeting:
 - a. Commissioner Dowser to contact Roy Ambury's brother regarding creation of a display of Roy's work.

a. Two Way Radios (Commissioner Dowser)

Commissioner Dowser discussed his report and put forward the following motion:

Kingston Area Taxi Licensing Commission (KATC) Motion To Amend and/or Replace Motion Number: 21-112 Date: September 5, 2021

2-Way Radio Systems

With respect to the recommendations and supporting Report 21-105, this motion is hereby presented to the Commission for first and second reading. A third reading of this motion will commence upon completion of consultation with the Industry and Public, with further recommendations to be implemented if any, and to be drafted and adopted by the Commission.

Bylaw No.2, sec.26, sub.4(h) and sub.4(l) (2019), states:

A Broker Shall:

- (h) supply the Licence Inspector with a copy of his/her/their/its federal radio licence call sign and frequency number, if any;
- (I) have his/her/their/its own separate radio system, frequency, and telephone system for receiving and dispatching calls for his/her/their/its own taxicab brokerage business, and shall not use another Broker's radio system, frequency or telephone system;

Bylaw No.2, sec.26, sub.5(a) (2019), states:

A Broker Shall Not:

(a) permit or allow any person other than a dispatcher or telephone operator to use any radio system, frequency or telephone system in his/her/their/its ownership or under his/her/their/its control, to receive or dispatch calls;

Therefore, shall be amended or replaced as follows:

Bylaw No.2, sec.26, sub.4(h):

(h) should the Taxi Stand Broker have in operation a federal licensed radio system, the Taxi Stand Broker must supply to the Licence Inspector a copy of their federal radio licence, call sign, and frequency number;

Bylaw No.2, sec.26, sub.4(I) (2019): (I) ensure that each Vehicle dispatched is equipped with a fully functioning global positioning system that is approved by the Commission.

Bylaw No.2, sec.26, sub.4(b) and sub.4(c) (2019), states:

(a) permit or allow any person other than a dispatcher or telephone operator to use any radio system, frequency, telephone system, or any other communication device or application in their ownership or under their control, to receive or dispatch calls;

Date of Commencement:

This amendment shall come into effect beginning October 31, 2021.
