William Wallace PATTON (Bill)  
Nov 20, 1935 – Jan 9, 2023

As you are probably aware we recently lost one of our elder statesmen, William (Bill) Patton on January 9th. The following was copied from his obituary although I did modify it slightly:

*"Dad fulfilled a childhood dream when he joined the Royal Canadian Mounted Police the day he turned twenty-one in 1952 and enjoyed a thirty-seven-year career with the Force with postings throughout Alberta. It was while serving as a young constable in Lethbridge that he met an auburn-haired nurse, and Dad & Mum had fifty-five wonderful years together. Following his retirement from the RCMP, Dad remained active in the community, serving as President of the Edmonton RCMP Vets Division and the RCMP National Veterans' Association as well as a dedicated volunteer with St. John Ambulance, Royal Life-Saving Society,*

*Edmonton Real Estate Board, and the Masonic Order. Dad was a consummate gentleman, who served his country with duty, and he had unquestionable integrity."* Further to the above, I believe Bill may have also served in "E" Division. He certainly was the consummate gentleman and will be missed!

Prior to the General Meeting commencing, we were fortunate to have Gerry Finlay, Legion Service Officer, who gave a highly informative presentation on the disability benefits available to the RCMP Veterans who have suffered work related injuries. He explained Legion Service officers are all security cleared and can provide representation or assistance with Claims and assist with the filing through My VAC Account. They help with documentation and forms, acquire and review members Service Medical Records, provide case recommendations, liaise with Service Providers such as Physicians, submit the file to Charlottetown for ruling and discuss the adjudication and resources. The type of service determines which Act is involved,

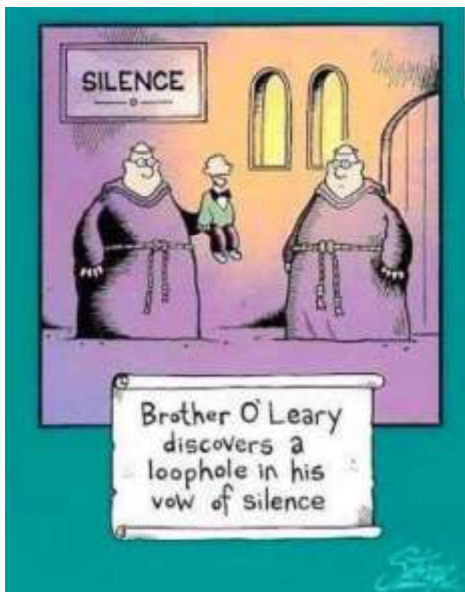


however, unless a member has previous military service, RCMP fall under the Pension Act. There is no time limit when claims can be filed, and they can also initiate on behalf of a Survivor (spouse). Benefits fall under Attendance Allowance and depending on the disability(s), there is also an Exceptional Incapacity Allowance. It's also particularly important to remember that once a member has acquired a benefit, reassessments can take place every two years. Reassessments can also be done if a member was denied a benefit.

**From the CO**

I hope everyone had a great start to the new year! This year is a significant year for us as we celebrate our 150<sup>th</sup> year. Celebrating the RCMP's 150<sup>th</sup> will take place in a number of ways, throughout the year. I will be sure to share those events as the year goes on, and I look forward to seeing many of you there.

**Unveiling of Supt. Griesbach statue at Alberta RCMP headquarters**

In November, we had an unofficial unveiling of a statue of Supt. Arthur Henry Griesbach of the North West Mounted Police at the “K” Division headquarters in Edmonton. The dedication of the statue to the headquarter grounds was an acknowledgment of the contributions and legacy of Supt. Griesbach who was an RCMP member of historical significance and is being recognized as the “first Mountie”. Emigrating to Canada from Britain after having served in the British military, Supt. Griesbach served with the military in Ontario prior to being tasked to assist in the research and development of a territorial policing force. This territorial force plan was submitted to the Canadian government in 1870 and was later used to develop the legislation authorizing the creation of the North West Mounted Police.

As the first officer to have taken the enlistment oath in 1873, and given the Regimental number 1, Supt. Griesbach went on to lay foundational work on which the RCMP organization was built. He took charge of establishing discipline and structure within the new force and was the primary Drill Instructor. From 1874 to 1901 before his retirement in 1903, Supt. Griesbach served at F, D, B, and G Divisions in various positions.

He is remembered as one of the original architects that formed the North West Mounted Police and what we know now today as the Royal Canadian Mounted Police.

As a monumental new addition to our courtyard for the public and employees, the statue honours Griesbach and his contributions to the establishment of the organization and his life spent in duty.

The statue is a solemn and respectful tribute to the long history of our organization and is our first commemorative piece for our 150<sup>th</sup> year. We will have much to share and showcase throughout the year while we keep optimistic about the future of policing service in Alberta.



## **Alberta RCMP Awards**

Also in November, we had our final Alberta RCMP Awards ceremony for 2022. These awards represent excellence through years of service, bravery, and dedication to the safety of citizens and give us the chance to recognize and reward RCMP members and veterans in their service. I feel privileged to participate and have the opportunity to recognize and reward those who have a deep-rooted commitment to contributing to the safety of our communities in Alberta. The awards are a way to recognize achievement and service and I am proud to be able to witness this.



As I've noted earlier this year, the significance of achieving service awards and commendations is impressive. Whether it has been a Long Service Medal, Police Officer Exemplary Service Medal, support to policing across the country, a St. John Canada Life-Saving Award, Commanding Officer's Commendation for Bravery, Outstanding Service, or Certificate of Appreciation, an Alberta Police Officer Long Service Award, an Alberta Emergency Services Medal, all of these very important awards represent excellence in service, dedication and commitment to the safety of Canadians.

I appreciate and thank all the RCMP veterans who have assisted with these important ceremonies and also received awards themselves. The valuable legacy and experience of service guides us as examples of excellence and inspires us in our continuing success as an organization.

### **Airdrie RCMP Crime Reduction Unit enhanced property crime enforcement project**

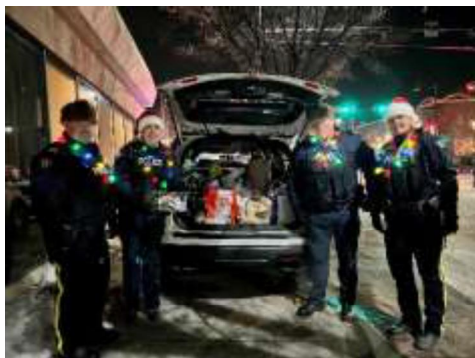
The Airdrie RCMP Crime Reduction Unit (CRU) engaged in an enhanced property crime enforcement project, in conjunction with retail Loss Prevention Officers, in both the City of Airdrie and County of Rocky View, over the month of December.

During the project, Airdrie CRU arrested or assisted in apprehending over 20 offenders, primarily related to theft, shoplifting, and stolen vehicles. The project resulted in 20 new criminal code charges and the execution of 38 outstanding warrants, for charges including robbery, possession of stolen property, fail to comply with conditions, fail to attend court, break and enter, theft and drugs.

Thanks to partnerships with Loss Prevention Officers and members of the community, Airdrie CRU were able to recover nearly \$35,000 worth of stolen property and return it back to their rightful owners before the holiday season.

### **Detachments participate in community charity events**

Participation and engagement with our communities is going to be an important part of our 150<sup>th</sup> year. Especially after a couple of years, being able to be active with community events is especially important to us now. During the holiday season and beyond, several detachments participated events with their communities.



In December, in Okotoks, thousands of people from the area poured into the downtown streets to take part in the 30th annual Light Up Okotoks Festival. This was the full scale Light Up festival for a few years and our Okotoks Detachment and officers participated in partnership with the local food bank by serving treats and spending time with local residents. In total, members raised \$471 in donation dollars, had \$320 in cook book sales, and donated 256 lbs of food.



Also in December, Leduc RCMP held their 4th Annual Stuff-a-Cruiser event in partnership with City of Leduc Enforcement Services and Vintage Towing in Leduc to support the Leduc District Food Bank. The team collected 2658 lbs of food and \$1940 in monetary donations. “The support from residents in Leduc and all the surrounding areas was phenomenal” said Constable Cheri-Lee Smith. “As the need to support our food bank grows, our community continues to step up and support those in need. We certainly appreciate everyone who generously donated and volunteered their time to make this event a success.”



In January, Innisfail RCMP and Innisfail Fire hosted the first annual battle of the badges charity hockey game. Hundreds of people attended the game with the arena at full capacity and after a hard-fought battle, Innisfail RCMP won at 15 to 10. In support of this event, the Calgary Flames alumni volunteered alongside the Town of Innisfail and they supplied players with Flames alumni swag along with a generous

donation of \$2500 to the Innisfail Food Bank. In total, the charity hockey game raised 1487 lbs of food and \$6038 in cash for the Innisfail food bank.

The 26th annual Innisfail RCMP Charity Checkstop also took place successfully in December. With the excellent assistance of community volunteers and partners and with the generosity of the community Innisfail raised a total of \$15,735.00 in cash and cheques. Additionally, almost three truck loads of high-quality toys and new clothing items were collected for the Innisfail Christmas Bureau and 542.2 pounds of food were donated to the Innisfail Food Bank by the citizens of Innisfail and the surrounding area. The charitable organizations that these items will be donated to are the: Innisfail Food Bank, the Innisfail Christmas Bureau, the Central Alberta Child Advocacy Centre and the Youth Positive Assets Coalition.



It's great to see detachments and employees participating and contributing to community events towards charity and local development. Engagement helps build strength in our communities and we will continue to build relationships with citizens and leaders across the province. We look forward to participating much more throughout 2023 and being able to celebrate the hard work of the employees and veterans in the special year of the Alberta RCMP's 150<sup>th</sup> celebration.

### **Barry Callbeck, Secretary:**

- Moved the minutes from the November 24/2022 Executive Meeting as published in the December Newsletter be adopted, seconded by Jerry Plastow – Carried
- Update from the Chief Firearms Office, the 577 is classed as an antique therefore does not fall under the same regulations as other firearms. We are awaiting Chief Firearms Officer's written report.

### **Kees Kikkert, President:**

- Kees indicated he is still updating the Division Manual but due to the new Association Manual this process is taking longer than he thought.
- There was discussion on the dues for members 90 years old and older to be paid for by our Division, however, this requires more investigation.

### **Vern Colley, Vice President;**

- Vern indicated he will meet with Jerry Plastow to review and put together a contact list of potential speakers.

**Jerry Plastow, Past President**

- The Social Committee has met and meals for the year have been set in place, as well as a short list of speakers. More speakers will be added as time goes on.
- There have been no donations requests of late, but a cash donation was made to be put towards the hampers. In discussion it was decided that hampers could be given out any time, Easter was mentioned as a good start, and all agreed.
- The Christmas Hamper for 2022 was very well received by the family. The hamper was delivered with assistance of members from Athabasca Detachment, who also brought gifts from the detachment.
- Two \$100 donations were sent to the Edmonton Veterans Food bank from the RCMP Veterans Foundation in memory of active members Lorne McKinstry and Pierre Lemonde. Jerry noted that if there is no mention of a donation in the obituary, he selects a local charity.

**Elaine Schnepf, Director - Boost Program:**

- Elaine told the Executive that we have lost three members this year and has been in contact with members who have health issues .

**Bruce Allen, Director:**

- Bruce is still working on the development of a new website for us.

**Eric Lafoy, Director:**

- With respect the RCMP 150, Eric has again reminded the committee members of our offer of financial assistance but for now, none have come forward.
- The Musical Ride is scheduled for Calgary during Stampede week, then to BC, then back to Alberta. Calgary Vets will be in the Calgary Stampede Parade and have approached the Calgary Stampede Association to permit the other Alberta RCMP Vets to join them in the parade and are still waiting for confirmation. The ride may also be in Ft Macleod this year but yet to be confirmed.
- 2024 is the 50<sup>th</sup> Anniversary of the first female troop, however the Force is suggesting to somehow incorporate their 50th Anniversary into the 150 celebrations in 2023. This is yet to be discussed at our next 150 meeting.
- Kees advised that Parkland Detachment will be hosting an event from 11:00 AM until 4:00 PM on May 27<sup>th</sup> at their Detachment and has requested some Vet volunteers. This will be looked after by Kees.
- The Alberta Aviation Museum indicated a desire to do something to help celebrate the two RCMP aircraft they have acquired and suggest a Banner outside could work.

**Tom Dunlop, Director Parking Passes:**

- Tom advised there are still members going to hospitals and forgetting to ask for the parking passes.
- Roger Goulet has advised he will be moving and therefore, can't be a contact for people to obtain the passes.
- Jim Medley will now take over that area. The information with respect to the contacts for parking passes will be updated and sent out to the membership.

- Dianne is on this committee as well as a subcommittee for Website Standards. The meet virtually seeking ways to restructure and improve means of communication especially the national website.
- There are actions towards the creation of less expensive website maintenance services, but this may be a two-year endeavour.

**b) National Collaborative PTSD – Atlas Institute**

- The Atlas Institute is a national organization that focuses on research and support for military and RCMP disabilities. One of the current initiatives is a Yoga research program for PTSD. Dianne has yet to sit in on a virtual meeting them but will report when she knows more.

**c) National Marketing**

- Through discussions with the Association CAO, Dianne advises she may have invented a new national marketing committee. Glen Siegersma and Dianne are heading this up and will report as it progresses. She strongly feels the Association desperately need a national marketing plan.

**d) Networking With Other Agencies**

- Vets Canada – Dianne is following up with this organization to keep in touch and share helpful information.



- Legacy Place - A home shelter organization (originally named: DIAKONOS HOUSE). She is encouraging the Executive Director to either make a presentation to our Executive or provide a snapshot of the organization, so we are better informed.
