Executive Summary:

The purpose of this report is to provide the Commission with an overview of the Standing Committee items discussed during its meeting held Tuesday, March 28, 2023, meeting number SC-02-2023.

1. Enforcement and Compliance

During the meeting of the Standing Committee, committee members and Standing Delegate (industry representative) Mark Greenwood, Owner of Amey's Taxi, a Broker, discussed the number of outstanding new taxi plates that remain unaffixed to taxicabs.

It was reiterated by the Chair, that the new taxi plates are the only Taxi Plates approved by the Kingston Area Taxi Commission, and since April 2022, the Kingston Area Taxi Commission has made numerous requests and demands, including the use of "warning based" issued tickets.

To date, there remains numerous taxicabs that have not complied. Mark Greenwood suggested that the office of Amey's Taxi should be contacted if the Commission or Enforcement Officers witness a taxicab (operating under Amey's Taxi) not have complied with the new taxi plate directive, whereas the office of Amey's Taxi would then "suspend calls" to the taxicab and direct them to the Commission's office immediately.

2. Public Awareness Campaigns (PSA's)

During the meeting of the Standing Committee, committee members and Standing Delegate (industry representative) Mark Greenwood, Owner of Amey's Taxi, a Broker, discussed the potential to initiate a public awareness campaign entitled, "Pay the Fare, It's the Law!", in response to the growing number of passengers "skipping out" on paying the fare indicated on the taxicab meter.

Both the Chair, Joseph Dowser, and Mark Greenwood openly shared and discussed with the committee members that despite the fact of the growing number of instances of Transportation Fraud, many cases of such are not reported simply due to the amount of time lost waiting for police to respond.

An example would be that should a passenger not pay the average fare of \$15, the amount of time waiting for police, plus any additional time off for court appearances, would cost more to the taxicab operator in lost business.

Committee members of the Standing Committee carried a motion to report back to the Kingston Area Taxi Commission regarding a Public Awareness Campaign (or PSA – Public Service Announcement) entitled "Pay the Fare, It's the Law!". This effort may help deter future Transportation Fraud, protecting the operators of taxicabs and the public. Artwork is attached to this report as "Exhibit A."

Transportation Fraud is defined under the Criminal Code of Canada as:

393 (3) Every one who, by any false pretence or fraud, unlawfully obtains transportation by land, water or air is guilty of an offence punishable on summary conviction.

The offence carries a maximum penalty of up to six months in jail and a criminal record.

As with any fraud related offence, which is a crime of dishonesty, it can have a severe, permanent negative impact on a person's reputation, travel, and employment opportunities. Like other criminal offences, most people who are charged with this crime have no idea how serious it is until it is too late.

Furthermore, it is with hopes that the City of Kingston, Loyalist Township, and Kingston Police assist the Kingston Area Taxi Commission and operators of taxicabs by sharing the public awareness campaign on their social media outlets.

1. Call / Trip Logs

During the meeting of the Accessible Committee, committee members and Standing Delegate (industry representative) Mark Greenwood, Owner of Amey's Taxi, a Broker, discussed the outstanding information requested from Accessible Plateholders specific to Call/Trip Logs.

The Chair reiterated that the Kingston Area Taxi Commission made its request to the accessible taxi plateholders on or before December 2022, and, that in January 2023 a formal demand pursuant to Section 5, subsection (a), (b), and (f) of By-Law Number 3 was issued.

To date, only one accessible plateholder has submitted the required documentation.

2. Accessible Vehicles

During the meeting of the Accessible Committee, committee members and Standing Delegate (industry representative) Mark Greenwood, Owner of Amey's Taxi, a Broker, discussed the outstanding information requested from Accessible Plateholders specific to Accessible Vehicles in service or operation.

The Chair reiterated that the Kingston Area Taxi Commission made its request to the accessible taxi plateholders on or before December 2022, and, that in January 2023 a formal demand pursuant to Section 5, subsection (a), (b), and (f) of By-Law Number 3 was issued.

3. New Plate Numbers

During the meeting of the Accessible Committee, committee members and Standing Delegate (industry representative) Mark Greenwood, Owner of Amey's Taxi, a Broker, discussed the outstanding information requested from Accessible Plateholders specific to new Accessible Plate numbers.

The Chair reiterated that the Kingston Area Taxi Commission issued its directive to the accessible taxi plateholders and taxi industry on or before April 2022.

To date, only one accessible plateholder has complied with the new accessible taxi plate directive having affixed this new plate to their accessible taxicab.

By-Law Number 3 states:

- 5. In addition to complying with all of the Accessible Taxi Plateholder responsibilities under this By-law, every Accessible Taxi Plateholder shall:
 - a) Ensure that the Driver of each Accessible Taxi keeps an accurate record of the number Trips made of Persons with Disabilities;
 - b) Record the total number of Trips made for Persons with Disabilities and for Persons without Disabilities from the Trip Sheets for each month, and maintains this recorded data for the duration of the Pilot Project.
 - f) Accessible Taxi Plateholders shall supply quarterly reports and an annual report on October 1st each year of all accessible calls received and costs of operating an Accessible Taxi for the duration of the Pilot Project.
