

# A MESSAGE FROM THE BOARD CHAIR

Our board works from a policy governance model. Overall, a board governance approach can help ensure our Centre operations focus on our mission and mandate and desired impact in the community.

As part of our commitment to transparency and accountability, we present our annual general meeting report for the Women's Centre. With the leadership of our policy committee, we have updated our board policies focusing on the following areas:

- Clarity about serving women, girls and survivors of sexual violence while working from a trauma informed intersectional feminist lens.
- We acknowledge and understand the harm of colonization, land acknowledgments help us remember the longstanding histories and legacies of colonization and enslavement that directly impact the communities we serve.
- We understand that gender identity refers to each person's deeply felt and internal and individual experience of gender which may or may not correspond with their sex assignment at birth.
- We value diversity and are committed to modeling diversity inclusion, and equity to maintain fair and equal treatment.
- Our board member duty descriptions, evaluations and committees add additional clarity and guidance including respectful organization guidelines.

- We have proposed amending the board terms allowing board members to serve up to two terms.
- We have strengthened our processes for complaint, dispute investigation and resolution including a policy specific to abuse allegations and prevention.
- We have developed a capital reserves policy to help strengthen our financial future.

Our policy work reflects our organization's commitment to providing high-quality services to women while advocating for women's rights addressing emerging issues. We will continue to update our policies and advocate for changes supporting the wellbeing of women in our community. We want to thank our staff, volunteers, members, funders and donors for their support and contributions to our organization's success. Together, we can continue to make a difference in the lives of women in our community.

# A MESSAGE FROM THE EXECUTIVE DIRECTOR

I want to express my deepest gratitude to all our members, volunteers, staff, funders, and donors who have supported us along our journey of empowering women and girls, enhancing their well-being. We have remained resilient, adaptable, and committed to our mission to empower women. We are steadfast in our commitment to a gender equal world.

We have faced challenges this year including increasing demands, cost of living increases and staff shortages. We have worked collaboratively and as a strong team to face these challenges and provide professional, quality and women centred services.

Throughout the year, we have sought and received grants and funding to address emergency food insecurity relief in the wake of Hurricane Fiona as women faced increasing challenges. We piloted a lunch and learn focused on food security.

March 8th, 2023, the province of Nova Scotia made a historic investment into women serving organization in the form of project funding and one time investment. We look forward to co-designing projects to address gender-based violence.

Our team provided one thousand two hundred and forty (1240) direct services to seven hundred and sixty one (761) women, girls, and survivors including supportive counselling services, advocacy, system navigation, information and referrals to women facing mental health problems, economic insecurity, and gender-based violence. We implemented a new MORPH group program aimed at addressing the day-to-day healing journey of survivors of sexual violence.

Our work does not end there. We have taken steps to create awareness about the challenges women face and the policies required to address them. In March, we had an opportunity to participate in discussions with Members of Parliament in Ottawa for a National Action Plan to End Gender Based Violence Day of Action following Canadian Women's Foundation Shockproofing Conference.

Along with Women's Centres Connect, nine women's centres across Nova Scotia we engage in various advocacy efforts to bring lawmakers attention towards issues such as the gender pay gap, the need for investments into non-profits as the social safety net of Nova Scotia, sexual health, housing insecurity and other important issues.

We hosted two in person events, Take Back the Night with survivors and allies bringing awareness while working towards an end of the public health emergency of ongoing gender-based violence. Followed by an Embrace Equity World Café International Women's Day Celebration featuring Tonya Francis and Sarah MacKinnon, participant in our Because I am a Girl International Day of the Girl program.

I want to take a moment to acknowledge and thank our staff and volunteers both past and present, whose hard work has made a significant difference in the lives of women in our community. Their dedication and commitment to our mission have been exceptional and the basis we continue to build from.

Looking ahead, we are committed to continuing our work in providing intersectional, trauma informed feminist services collaborating with women to achieve their full potential. We are committed to addressing the system barriers that hinder women's progress towards quality of life and will work towards building a more equitable and inclusive society.

I want to thank our Board of Directors for their leadership and guidance, our community for their continued support, our funders for the resources that keep our doors open and our donors for their generous contributions.

### **DIRECT SERVICES**

Our open-door policy welcomes women and survivors of sexual violence to receive support and information. We meet people where they are on their journey with a strength-based women centered trauma informed intersectional approach. We served two hundred and twenty one (221) new women this year, offering a full range of direct services.

We are the oldest Women's Centre in Nova Scotia operating for forty seven (47) years. Our direct services include support counselling, information, referrals, advocacy, and programs on a broad range of topics. We provided early intervention opportunity, helping empower and strengthen well-being through all our programs and direct services.

Nova Scotia Advisory Council on the Status of Women funds our core services which is enhanced by project funding. Project supports from Canadian Women's Foundation, United Way of Pictou County, Department of Community Services, Federal Student Program and Community Links increasing our capacity to meet growing demands for service. March 8, 2023, the Province of Nova Scotia made an announcement offering additional project and one time funding supports to Women Centre's for this coming year. Funding is essential to our capacity to provide services and expand in order to meet the growing needs of our community.



# MORPH - MAPPING OUR ROAD TO POWER AND HEALING

MORPH aims to support and empower survivors living in Pictou County. MORPH coordinated and provided services to survivors helping them develop healthy coping tools to manage and reclaim control of their lives. We collaborate with community partners including PSART (Pictou Sexual Assault Response Team) to respond, offer awareness, public education events and work towards a coordinated response to sexual violence.

MORPH services received project funding through both the Canadian Women's Foundation and United Way of Pictou County.

With funds from the Canadian Women's Foundation, we have been able to contract a counsellor offering both group and individual services to survivors. Our services include counselling, safety planning, information, referrals, programs, and public education.

Our MORPH support worker, Melissa Fanning, plays a significant role in this service delivery and coordination.

Over the last year, we have completed twenty four (24) sessions in groups involving twenty three (23) participants. Group offers a unique opportunity to gain experience and grow through group experience.

MORPH Counsellors, Janice Fraser, Anna Galvin, and Melissa Fanning co-facilitated these programs.

THERE WAS A 24% INCREASE IN THE DEMAND FOR GENDER-BASED VIOLENCE SERVICES. OVER THE LAST YEAR, GENDER-BASED VIOLENCE WAS THE REASON FOR SERVICES TWO HUNDRED AND SIX (206) TIMES AND A CONTRIBUTING FACTOR FOR ACCESSING SERVICES AN ADDITIONAL TWENTY EIGHT (28) TIMES.

### GIRLS EMPOWERMENT

We believe empowering girls is essential to creating a brighter future for all. We recognize the unique challenges girls face in their daily lives, and are committed to providing them with tools, and programs they need to thrive.

We recognize empowerment is a process that starts with self-awareness, self-esteem, and confidence. We provide a supportive environment where girls can explore their own values and beliefs while developing skills to express themselves, advocate for themselves and pursue their dreams.

We promote gender equality and challenge harmful stereotypes, biases and discrimination that can limit girls' potential. We aim to provide them with opportunities to develop their full potential and become agents of positive social change.

Our work with girls occurs through programing including girl's empowerment camps, International Day of the Girl Celebrations and Finding Me School Based Program.

This year we were able to hold our Girls Summer Camps in-person serving four (4) communities including Ward One, Downtown New Glasgow, Pictou, and Pictou Landing First Nations. There was a total of thirty six (36) girls participating in the camps. International Day of Girl events distributed eighty (80) Because I am a Girl Books. While working in six schools, with one hundred thirty seven (137) students with our Finding Me Program.

With food security grants we offered healthy snacks and lunches. Thank you, United Way of Pictou County, for your support!



# SCHOOL OUTREACH PROGRAMS

Finding Me started in 2018 with grade seven girls. It is an eight-week program providing girls a safe space to learn, grow, and inquire about topics connected to wellness, relationships, and sexual violence prevention. With funding from the United Way of Pictou County, we were able to update this program in March 2023. We extend a special thanks to Schools Plus for their partnership and extra support with co-facilitation in West Pictou and Trenton schools.

### **SOCIAL CHANGE**

Our dual mandate ensures we provide both direct services and work for social change.

As long as we have inequality, we will have gender-based violence, poverty, and a lack of access to the social determinates of health. Equality is the path forward to a gender equal world. To achieve this, we all need to work together towards a secure and resourced community.

We are in a public health crisis, with most women experiencing gender-based violence in their lifetime. It is our hope we can work within the national action plan to end gender-based violence to increase awareness, resources, and strategies to end gender-based violence.

We raise public awareness through five social media campaigns, five public education and events. We continue to work within the community through seven local tables and networks and four provincial groups.

# WOMEN'S CENTRES CONNECT

Connect is our provincial association of Women's Centre's. Connect unites nine Women's Centres from across the province to offer a gendered analysis on policy and speak up about women's issues provincially. Connect member Centres serve and respond to the issues of women and girls in our communities. Our activities are rooted in a feminist analysis informed by an intersectional, non-oppressive, and trauma informed approach.

#### **POLICY & ENGAGEMENT & ADVOCACY**

Connect and each of the nine women's centres participated in a number of policy engagement and advocacy opportunities over the last year. As Connect acts on consensus, we offer a formidable voice on issues and solutions related to the social determinants of health, equality and equity. We continue to uphold Connect's advocacy through engagement with several organizations with similar missions. The following are some examples of Connect's advocacy during the past year.

- Ongoing lobbying for of Sexual Violence Trauma Therapy Services RFP throughout the province.
- Engaged with Canadian Women's Foundation via a survey on a project to explore a vision and path towards achieving a thriving women's and gender equality sector.
- Contributed to the report "Not Without Us" with the report: Changing the Response for Women with Disabilities Experiencing Domestic Violence.
- We signed onto a letter for the Federal Government to include funding for energy efficiency for lower income households in the 2022 budget.
- We signed the Disability Rights Coalition letter Lobbied Columnist Sheldon MacLeod on: Power poverty in Nova Scotia and calls to action.
- Wrote a letter to the Premier with respect to the Child and Youth Commission and made suggestions on support while children are in care relating to Intimate Partner Violence.
- Opportunity with YWCA who is partnering with Schools Plus to get prevention education around trafficking and exploitation of youth into the schools.

- Continuum of Care Research Project.
- Added to a social media campaign on Abortion rights in NS.
- Engaged with Msit No'kmaq: Indigenizing Nova Scotia's GBV Response.
- Knowledge Synthesis Research Project with Dr. Katherine Salter to explore the relationship with precarious employment and violence against women.
- Have signed a letter to support Efficiency Canada and are looking into Carbon embedding in various industries.
- Participant in the VAW research project with Dr Alexa Yakubovich
- Engagement with Canadian Council on Rehabilitation and Work, a nonprofit organization assisting individuals with disabilities to find and maintain meaningful employment.
- Signed on to support our consensus statement outlining the principles for a basic income guarantee (BIG) we would like to see implemented in Atlantic Canada.
