- Minimum of 1 or more years work experience as a massage therapist.

- Must carry liability insurance.

(Required for all countries where you have resided for more than 6 months or longer, in the past 10 years.

- **Evidence that you meet the requirements of the job offer and your work experience and employment history, such as:**

1. Letters from current and past employers specifying your position, duties, earnings;
2. Payslips/ Payroll bank statements.
3. Evidence of contributions to social insurance regimes working as Beautician in a Salon (eg. SSS); proof of payroll deposits;

- **Proof of education:** Copies of related/relevant education certificates as esthetician/beautician, school transcripts, School Grades, diplomas, degrees, TESDA Certificates as Beautician.
