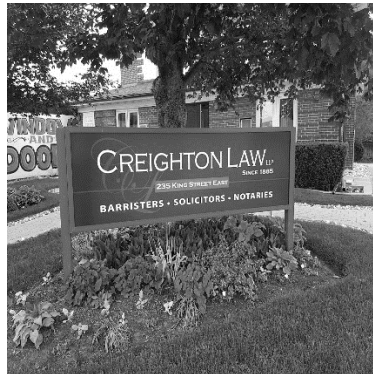
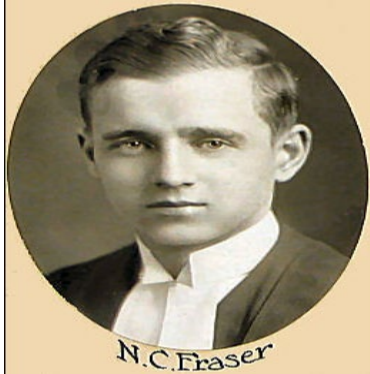

## Brief History of Creighton Law LLP

Creighton Law Firm was founded in Oshawa, Ontario by three original members, Lieutenant Colonel J. F. Grierson, Thomas Kelso Creighton and Neil Fraser. Grierson founded J.F Grierson Law when he returned from the 1885 Riel Rebellion. He served on the Oshawa Council for 6 years, as a member of the Library Board for 50 years and served as the town solicitor of 50 years. He was also instrumental in incorporating Oshawa as Ontario's 25<sup>th</sup> city in 1924. A name change occurred in 1919 when Kelso Creighton joined the law firm, then becoming Grierson & Creighton. In addition to the law firm, Creighton served as the MPP for Oshawa, the City Solicitor, Magistrate, Bench or Law Society of Upper Canada, and as a member of the Oshawa Police Commission. Grierson & Creighton changed names once again in 1935 when Neil Fraser joined their ranks. A prominent lawyer, Fraser served with distinction as Judge Advocate General of the 2<sup>nd</sup> Corp and was made a Member of the British Empire. In 1961, he was appointed as a Justice to the Supreme Court of Ontario. The law firm of Grierson, Creighton, & Fraser would serve as one of the main law firms in Oshawa for many decades in the early 1900's. One final name change in 2013 to Creighton Law LLP, marked the firm's current era. Creighton Law LLP remains one of Canada's oldest law firms and is still one of the major firms in Oshawa.

## Collection Description

This collection includes land deeds and related legal papers, blueprints, and wills and related documents. It was collected and donated by the Creighton Law Firm to the Oshawa Museum in 2024. The collection will remain open to allow for more donations from Creighton Law in the future.

## Arrangement Description

This collection was processed at the collection level then divided into twenty-five series.
