NO WATERING ON:

Mondays, Thursdays & Fridays

Residents on South and West side of the street watering days are Tuesday & Saturday

Residents on North & East side of the street watering days are Wednesday & Sunday

(On watering days no watering between noon—5pm)

NOTICE OF MAILING OF 2021 ASSESSMENT NOTICES

TOWN OF STAVELLY

Under the provisions of Section 311 of the Municipal Government Act, Chapter M26.1, notice is hereby given that assessment notices for property within the Town of Stavelly will be mailed as of June 7, 2022. Under the provisions of Section 308 the 2021 tax notices and assessment notices are combined in one notice. The assessment roll will be open for inspection for a period of 60 days at the Municipal Office of the Town of Stavelly, during normal business hours. Any person who desires to object to the assessed value as set out in the assessment notice must, within 60 days from the date of this notice, lodge a complaint in writing with the Municipal Administrator of the Town of Stavelly.

NOTICE OF ASSESSMENT APPEAL FEE

Under the provisions of Sections 481(1) & (2) of the Municipal Government Act, Chapter M26.1, notice is hereby given that a fee of \$20.00 per parcel shall accompany all assessment appeals, refundable in the event of a successful appeal.
