The 1st cheque to be dated **July 1.2020** and 2nd cheque to be dated **Oct.31. 2020**. **Only half of work hours and one work bee** are to be completed by July 1. Deposit cheque will then be destroyed or returned. The 2nd deposit cheque will be returned or destroyed after **remaining** work hours and bee are completed. Anyone i.e. friends or family may complete the work hours or bees for you. If your work hours are not completed, **the cheques will be cashed without further notice.** **No rider will be allowed to ride as a member in any event until post-dated cheques and proof of current Horse Council BC membership is received.**
